

The State of Missouri Alcohol Responsibility Training (SMART) program is an interactive, web-based course available free of charge to those who own or work for any Missouri establishment licensed to sell alcohol.

Benefits of SMART

- No classes to attend; SMART is available 24 hours a day, 7 days a week, anywhere with an internet connection
- Managers are able to customize the training to include establishment policies including forms of IDs accepted, age of persons allowed to enter, and more
- Possible credit on liquor liability insurance with 100% employee certification (Talk to your insurance company about this option)
- The Division of Alcohol and Tobacco Control fully supports the SMART program, and participating in this program will be considered when determining the extent of the retailer's efforts to prevent violations
- It takes approximately one hour to become certified through the SMART program
- Accounts belong to each individual user
- Users can connect with multiple establishments
- Certifications are valid for 2 years after certification date
- Users can request and change their log-in information 24/7
- Training can be translated into several languages, including Spanish, via Google Translate

The SMART program educates sellers and servers of alcoholic beverages about their legal obligations concerning the service of this highly regulated product. Servers in bars and restaurants can take a certification exam related to their work, and sellers who work in retail outlets take a different version.

Bars and restaurants

- Prevention of services to minors
- Typical signs of intoxication
- Advice on how to handle disorderly, intoxicated customers
- Laws and liability concerns related to selling to underage or intoxicated customers

Retail outlets

- Typical signs of 3rd party transactions
- Advice on how to prevent alcohol theft
- Laws and liability concerns related to selling to underage or intoxicated customers

To create an account

Individuals/Sellers/Servers

- Visit smartmo.education and click on the orange button 'Click Here to Access the SMART Training Program'
- Click 'SMART Registration' on left hand side of the training site and enter your information into the prompted fields
- Use your personal email to create an account
- A password will be emailed to the email account you provided
- Use the password and your email address to access your account

To connect with an establishment where you work, click the 'Relationship' tab, and enter their liquor license number. If you don't have the liquor license number, you may search via the 'License Lookup' tab.

Managers

- To create a manager account, you will first need to create an account as a individual/seller/server, as instructed above
- After you have created your individual account, you can add the 'manager' side of your account by clicking 'Manager View Registration' on the training homepage, and entering your email, password and establishment liquor license number

Note: There can be only one manager account per establishment, so verify that you are authorized by your employer to create a manager account.
